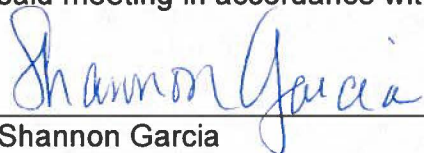

Public Works Director Appointment

DESCRIPTION:

Consider a memorandum/resolution approving the City Manager's appointment of Jim Reed as the Public Works Director.

BACKGROUND:

The Director of Public Works position has remained vacant since July 2025. Two qualified applications were received during the recruitment process.

A hiring committee consisting of the City Manager, Assistant City Manager/Chief Financial Officer, Lorena City Manager Kevin Neal, and former Waco City Manager Wiley Stem reviewed applications, conducted interviews, and unanimously selected Mr. Jim Reed as the top candidate.

Mr. Reed has more than 46 years of combined public service, transportation, and project management experience, including:

- City of Waco – Transportation Planning Manager (current), working within Infrastructure Services to develop regional planning and mobility strategies (GIS project visualization, alternative mobility, Safe Routes to School, transportation grants)
- City of Waco – Streets Division Manager, supervising 56 employees and managing fleet/equipment, road maintenance, right-of-way operations, and annual budgeting
- City of Waco – Capital Improvements Program Manager, overseeing 130+ capital projects totaling more than \$295 million in water, wastewater, and street improvements
- Texas Department of Transportation – 27 years, including serving as Local Government Project Manager, negotiating 62 project funding agreements and administering FHWA compliance, audits, and construction phases

He also holds an Associate's Degree in Architectural Design and Drafting from Texas State Technical College and maintains OSHA 510 – Construction and TxDOT Local Government Project Procedures (LGPP) certifications.

Mr. Reed expressed a mission-driven desire to join Bellmead specifically as a community where meaningful impact and organizational transformation are possible — a factor that distinguished him from other applicants.

Calling the May 2, 2026, General Election

DESCRIPTION:

Consider a memorandum/resolution calling and ordering a general election to be held on May 2, 2026, for the purpose of electing Precinct 3, Precinct 4 and At-Large Council Members, all for a Two Year Term; Providing for the Designation of the Places and Manner of Holding Said Election; Providing for the Designation of Early Voting Polling Places; Providing for the Posting and Publication of Notice; and Authorizing the City Manager to Execute all Documents Related thereto on Behalf of the City of Bellmead.

BACKGROUND:

Under the provisions of the Charter of the City of Bellmead, a general election shall be held on May 2, 2026. The terms of office for Precinct 3, Precinct 4, and At-Large Council Members will expire in May 2026 and must be filled by general election.

The contract with the McLennan County Election Administrator will be brought before the Council at the March 10, 2026, Council Meeting.

Staff recommends that the council consider having the county run its elections to avoid potential challenges to the process's integrity and mitigate the risk of litigation or appeals.

Engaging the county is projected to cost between \$2,500.00 and \$ 4,500.00, whereas the city's costs are estimated to be significantly higher at \$7,500.00 to \$10,000.00. These amounts may vary depending on the number of entities holding elections concurrently.

Staff is committed to minimizing expenses in either scenario but has confidence that, under Jared Goldsmith's leadership, the county will manage the election with high integrity.

This approach offers a more cost-effective and reliable solution for conducting the election.

DESCRIPTION:

Consider a memorandum/resolution denying the application for a zoning change from R-2, Duplex and Apartment District to B-2, Secondary and Highway Business District.

BACKGROUND:

The owner has applied for a change in zoning for 9.87 ac. of land located at 1511 Old Dallas Road. The property was recently platted as Lots 1 and 2, Block 1, Fredi Addition.

The property has several uses currently, including a well-maintained single-family home that was constructed in 1903 according to tax records. The property also has a large motor vehicle repair shop; sand & gravel excavation and storage; and possibly the keeping of roosters.

The general area is a mixture of single-family residential homes and heavy commercial business operations. There is a long-established paint and body shop immediately to the south, as well as a very large rooster facility, and the sand and gravel excavation in the area appears to have been occurring for a long time.

The property owner approached the city to secure permits for construction of new metal buildings on the property. He was advised that the property was not platted and that the zoning would not allow for the expansion of the auto repair business. He was advised that platting and rezoning was needed.

This application, if approved, will legitimize and make existing business legal and bring the property into compliance with appropriate land use regulations.

City Council conducted the required public hearing and considered the request during the October 14, 2025, meeting.

Following discussion, Councilman Gibson requested that the item be tabled until the next meeting so they could visit the site, speak with residents, and better understand the potential impact of converting the property from residential to commercial. The motion to table was approved unanimously and an opportunity for council to visit the site on October 21, 2025, was posted. Council members Bainbridge, Cleveland and Moore visited the site.

The rezoning request was placed to the November agenda for consideration. The item was again tabled for consideration in January 2026. Staff will move as directed.

PLANNING AND ZONING COMMISSION RECOMMENDATION:

Following a public hearing held on September 16, 2025, the Planning and Zoning Commission voted 4 – 0 to recommend denial of the requested change from R-2 to B-2.

Staff recommends denial of the application in conjunction with the Planning and Zoning Commission.

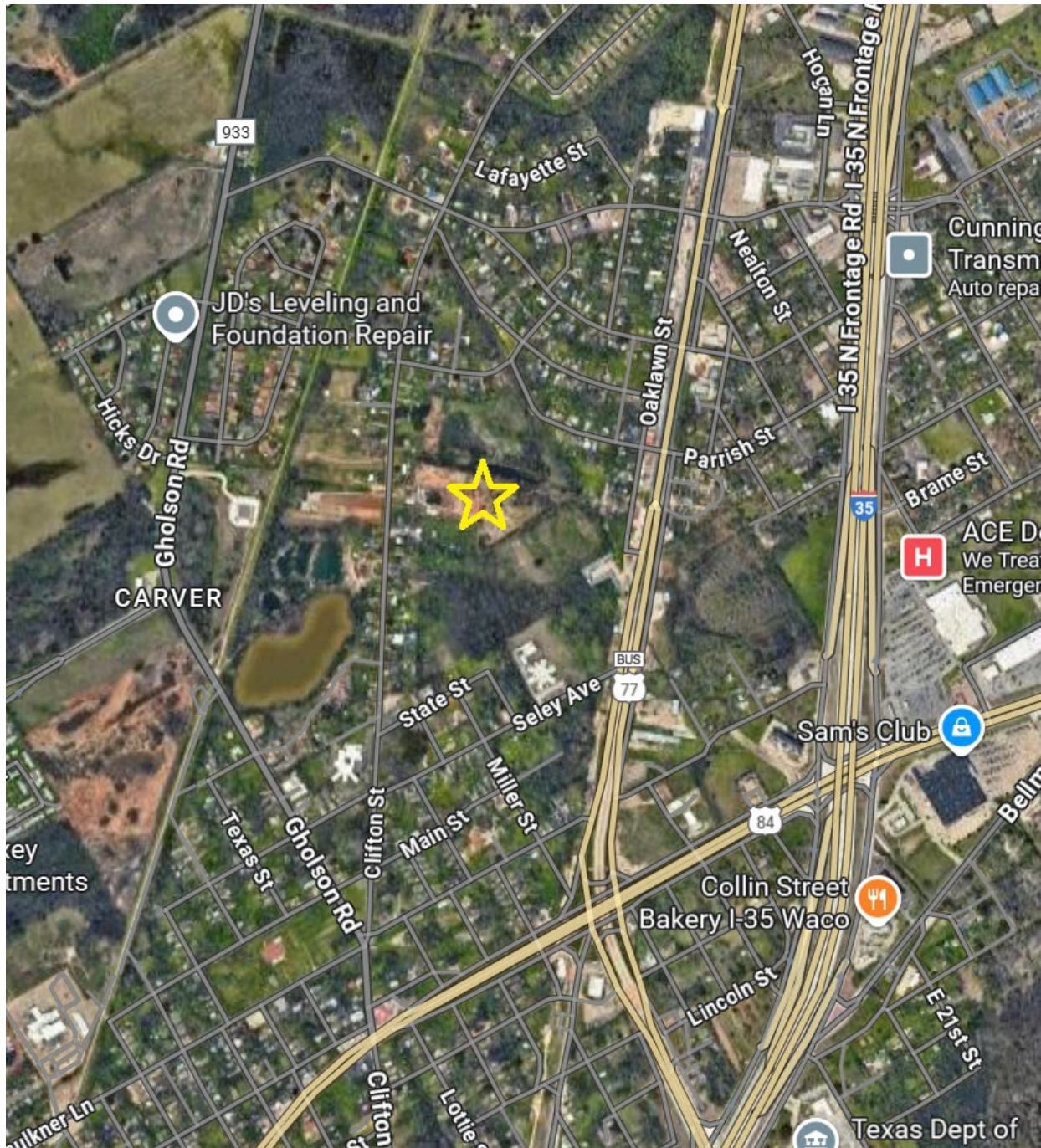

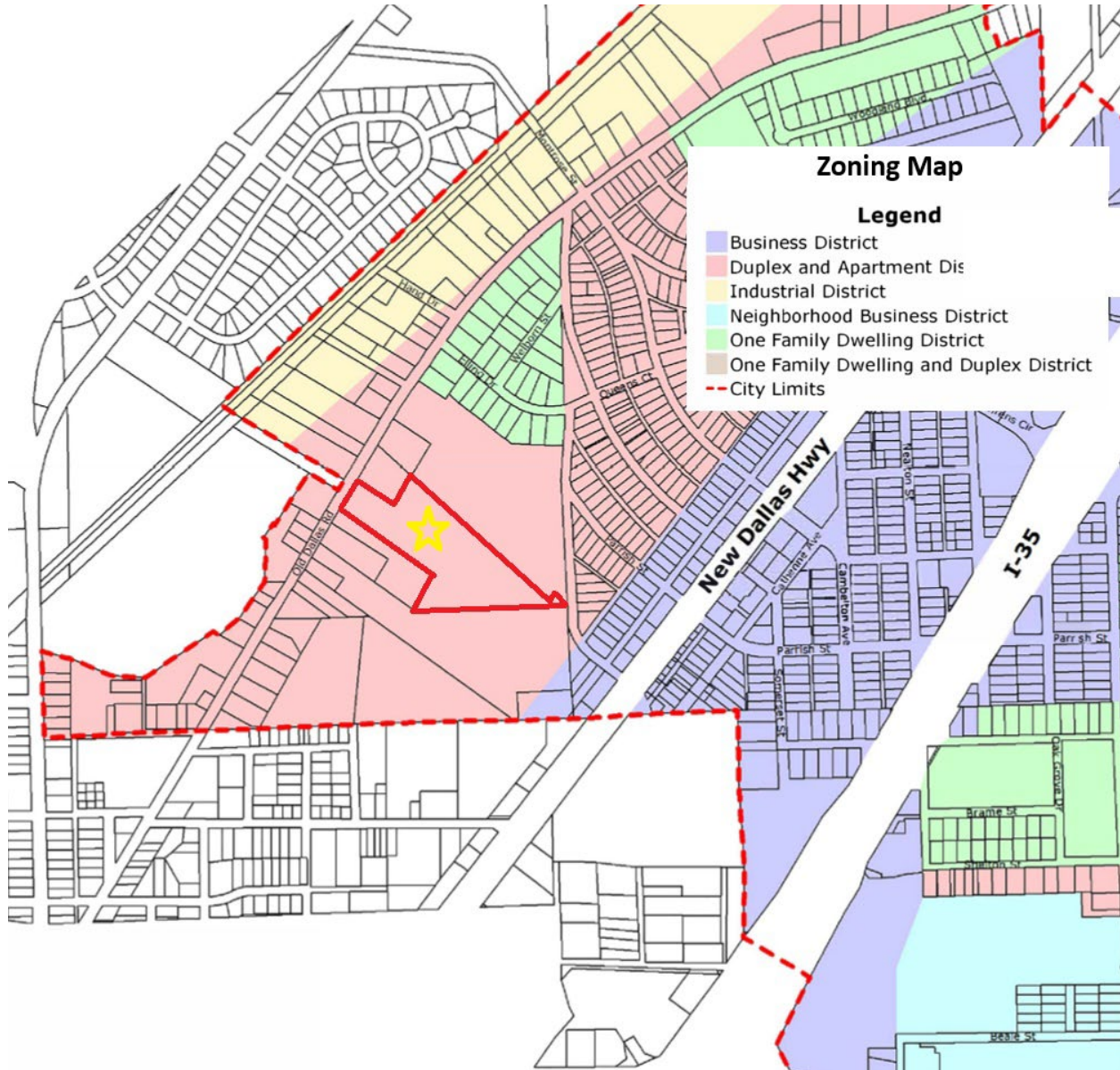

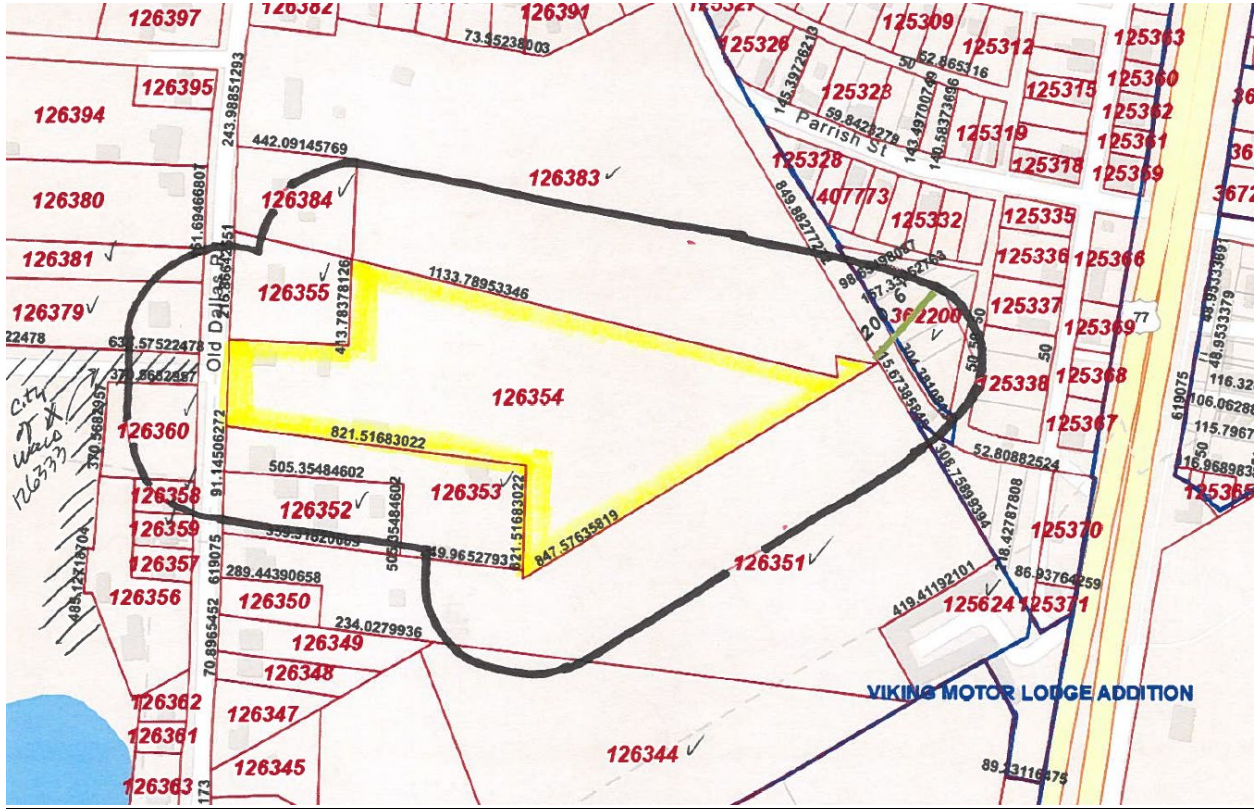
Location Map:
