Master Fee Schedule

DESCRIPTION:

Consideration and approval of an ordinance amending the Master Fee Schedule, attached as "Exhibit A" for the Bellmead Code of Ordinances, Appendix B; Repealing all ordinances or parts of ordinances in conflict herewith; providing severability; providing for inclusion in the code; and, providing for an effective date.

THIRD AND FINAL READING

BACKGROUND:

This item proposes amending Appendix B (Master Fee Schedule) of the Bellmead Code of Ordinances to implement new and revised fees associated with two ordinances being considered for adoption at this same City Council meeting. The fee adjustments will ensure the City can administer, enforce, and recover costs related to the implementation of these ordinances upon their adoption.

PROPOSED FEE CHANGES

1. Coin-Operated Machine Ordinance

This ordinance removes obsolete provisions referring to 8-liners and game rooms and clarifies regulation of legal amusement machines.

Fee Schedule Updates:

- **Game Room License Fee:** Removed from the schedule.

2. ROW & SWF Ordinance

This ordinance regulates both public right-of-way activities and the installation of small wireless infrastructure, ensuring coordination, protection of City assets, and compliance with state law (Texas Local Government Code Chapter 284).

New Fees Added to the Schedule:

The ordinance establishes standards for construction activities in the public right-of-way and regulates installation of small wireless infrastructure to protect City assets, improve coordination, and comply with Texas Local Government Code Chapter 284.

New and Revised Fees for ROW Permits:

- **Construct Street, Driveway Approach, Sidewalk, or Curb (Including Inspection):** \$50 (*adjusted from previous \$35 fee to better recover administrative and field costs*).
- **Excavation (Open Cut, Bore, Tunnel, or Surface Removal in ROW):** \$75 per dig (*adjusted from previous \$50 fee to better recover administrative and field costs*).
- **Utility Installation in ROW (Non-Excavation, e.g., aerial or surface-mounted work):** \$50 per location (*new fee*).
- **Traffic Control Plan Review (where required):** \$50 per plan (*new fee*).

New Small Wireless Facility (SWF) Fees (Based on Statutory Maximums in Texas Local Government Code Chapter 284):

- **Network Node Site Fee:** \$250 per network node per year (Tex. Loc. Gov't Code § 284.053(a))
- **Support Pole Fee:** \$250 per pole per year (Tex. Loc. Gov't Code § 284.054(c))
- **Transport Facility Fee:** \$28 per facility per month (Tex. Loc. Gov't Code § 284.055(b))
- **Collocation on City-Owned Service Poles Fee:** \$20 per service pole per year (Tex. Loc. Gov't Code § 284.056)

3. Wireless Tower Zoning Applications

To support administration of wireless infrastructure siting, the following fees have been added under Planning & Zoning:

- **New Wireless Tower Construction Application:** \$200
- **Wireless Tower Modification Application:** \$75

4. Memorial Brick Program

To facilitate a new memorial program dedicated to our nation's veterans. Bricks will be sold at a rate of \$100 to memorialize veterans and placed in Memorial Park located in front of Municipal Court.

5. Civic Center Rental Rate Updates

Revised fees reflect market adjustments and facility demand.

FISCAL IMPACT / FUNDING SOURCE:

The proposed fee updates provide cost recovery for permitting, compliance inspection, and administrative activities associated with the new ordinances. No negative impact to the General Fund is anticipated.

STAFF RECOMMENDATION:

Staff recommends approving the Master Fee Schedule, attached as “Exhibit A” for the Bellmead Code of Ordinances, Appendix B; Repealing all ordinances or parts of ordinances in conflict herewith; providing severability; providing for inclusion in the code; and, providing for an effective date. **FIRST AND SECOND READING**

**CITY OF BELLMEAD
ORDINANCE NO. 2025-007**

AN ORDINANCE OF THE CITY OF BELLMEAD, TEXAS AMENDING THE MASTER FEE SCHEDULE ATTACHED AS EXHIBIT "A", FOR THE CITY OF BELLMEAD CODE OF ORDINANCES, APPENDIX B; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH, PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in the event there is a conflict between a fee listed in the Master Fee Schedule, this ordinance is not intended to abolish or change any fee hereto established that is not listed in the Master Fee Schedule.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BELLMEAD, TEXAS:

SECTION 1: That from and after the effective date of this Ordinance, the fees and charges set out in the Master Fee Schedule attached hereto Exhibit "A" shall be collected on behalf of the City. Other sections, fees or charges not referenced in Exhibit "A" shall remain unaffected by this Ordinance.

SECTION 2: That in the event of a conflict between a fee set out in the Master Fee Schedule and the provision of any other City ordinance or resolution, the provisions of the Master Fee Schedule shall prevail; however, this Ordinance shall not amend, abolish, or change any fee heretofore all purposes until amended by ordinance or resolution or transferred to the Master Fee Schedule.

SECTION 3: That all ordinances or resolutions or parts of ordinances or resolutions in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION 4: That should any section or part of any section, paragraph or clause of this ordinance be declared invalid or unconstitutional for any reason, it shall not invalidate or impair the validity, force or effect of any other section or sections or part of a section or paragraph of this ordinance.

SECTION 5: That the Code of Ordinances of the City of Bellmead, Texas, as amended, shall remain in full force and effect, save and except as amended by this ordinance.

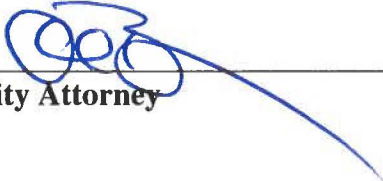
