

Contract Terms for Athletic Rental Facilities

1. Renter must provide proper identification. (Must be 21 years of age or older).
2. The renter is entitled to use only the area designated in the Rental Agreement.
3. All equipment must be removed from the site at the conclusion of the event.
4. Renters may not have private contract instructors or vendors operate on the premises without written approval from the City of Bellmead Parks and Recreation Department. All vendors must be directed to the City of Bellmead PARD to obtain a vendor agreement.
5. **Reservations are not final until payment is made in full, and all proper documentation is received.**
6. The person making the reservation is responsible and must be on site during the event. The renter should always keep a copy of the rental contract with them.
7. Facility must be cleaned, left in proper order and all equipment, cords, vehicles removed at the completion of the rental. The City of Bellmead is not responsible for items and equipment left on the grounds.
8. Smoking is only allowed in designated areas.
9. The reserving party assumes responsibility for crowd control/discipline.
10. The City of Bellmead reserves the right to cancel any ongoing event for rental agreement violations, violation of city ordinance, breach of peace or inability of the reserving party to control participants or spectators. The reserving party of this agreement will be held responsible for damage to City of Bellmead property resulting from use herein.
11. The holder of this contract shall indemnify and hold harmless the City of Bellmead, its officers, employees, agents and assignees from any and all claims for injury and/or damages to persons or property, including wrongful death, resulting from the use of these facilities. The agreement holder must carry contract on person at the dates requested or agreement will not be valid.
12. Parking is allowed in designated areas only. Absolutely no vehicles are permitted on the fields or on the grounds surrounding the field without authorization from a City of Bellmead representative.
13. No more than three (3) reservations can be maintained at one time by the same team or individual for practice.
14. Please abide by the rules set forth concerning the consumption of alcohol in City facilities. Absolutely no alcoholic beverages are allowed on the fields or in the dugouts. **IT IS ILLEGAL TO BRING ALCOHOLIC BEVERAGES INTO LION'S BALLPARK.** Violators will be removed from the ballpark and are subject to suspension from the park for a time to be determined by the City of Bellmead. **REPEAT OFFENDERS ARE SUBJECT TO A MINIMUM 1 YEAR SUSPENSION FROM LION'S BALLPARK.**
15. Please comply with the occupancy limits including special limits required by health conditions, Park rules, as well as any City, County, State, and Federal Guidance, Orders and Declarations.
16. All renters and event attendees must comply with requests and instructions from any City official at the event.
